# **April 12, 2017**

The Bengal Township Board meeting was brought to order by Supervisor Schafer at 7:00 pm.

The **Pledge of Allegiance** was said and the meeting commenced.

Treasurer Schultheiss moved to accept the **agenda** as presented, supported by Trustee Kushmaul, motion carried.

Supervisor Schafer moved to accept the **March 8, 2017 meeting minutes** as presented, supported by Trustee Kushmaul, motion carried.

The March 29, 2017 Budget meeting minutes were reviewed, Treasurer Schultheiss recommended adding "for fiscal year 2016/2017" to the Treasurer's Report portion of the minutes. Treasurer Schultheiss moved to accept the minutes as amended, supported by Trustee Kushmaul, motion carried.

Treasurer Schultheiss presented the **Treasurer's Report** with handout. She presented the completed fiscal yearend report for 2016/2017. Supervisor Schafer made a motion to accept the treasurer's report as presented, supported by Trustee McDonald, motion carried.

Clerk Bassette presented the new **bond insurance** from Burnham and Flowers. Treasurer Schultheiss moved to approve the Burnham and Flower's bond insurance as presented and effective 04/01/17, Supervisor Schafter supported, all in favor.

Clerk Bassette brought an **Application for Farmland Agreement for PA116** in the name of T.M. Irrer LLC, discussion commenced. The Irrer's were in attendance and answered any questions.

Treasurer Schultheiss moved to accept the bills to be paid as revised, supported by Trustee McDonald, motion carried.
