The Bengal Township Board meeting was brought to order by Supervisor Schafer at 7:00 pm.

Supervisor Schafer moved to accept the **agenda** as revised to add "St. Johns Fire Contract" after assessor contract and to omit "public hearing", supported by Trustee Kushmaul, motion carried.

Trustee Kushmaul moved to accept the **03/13/19 and 03/27/19 meeting minutes** as presented, supported by Supervisor Schafer, motion carried. Clerk Bassette abstained from the 3/27/19 minutes approval.

Treasurer Schultheiss presented the **Treasurer's Report** with handout. Clerk Bassette made a motion to accept the report as presented, supported by Supervisor Schafer, motion carried.

Clerk Bassette presented the **Clerks Report.** Treasurer Schultheiss moved to accept the clerks report as presented, supported by Trustee Kushmaul, motion carried.

Supervisor Schafer presented a **resolution for elected offices to appear as nonpartisan on the ballot**. Clerk Bassette did a roll call vote: Schafer, yes; Schultheiss, yes; Kushmaul, yes; Bassette, yes; McDonald absent. Supervisor Schafer declared Resolution 2019-05 approved.

Supervisor Schafer presented and requested approval of the 13 road projects contracts for 2019/2020 fiscal year. Treasurer Schultheiss made a motion to approve the contracts as presented, Trustee Kushmaul supported, motion carried.
