Regular Board Meeting

Call to Order – Roll call – present: Sillman, Pung, Bassette, Boak; absent: McDonald

Public Comment on Agenda Items – Suzy Williams discussed the importance of getting the bridge on Dexter Trail road fixed, pointing out the extra time it will take emergency vehicles from Dallas Township to get to the properties on Dexter Trail.

Lynda Roof and Suzy Williams gave the **Delegate Report**, they shared information about what a delegate does within the township adding that Steve Lewis from Bath area leads the county delegates.
