The Bengal Township Board meeting was brought to order by Supervisor McDonald at 7:00 pm.

The resolutions reflect the annual \$3.00 per capita and the additional, one time, \$3.00 per capita approved previously by the board to pay for updating equipment by CAASA, and to authorize CAASA to purchase and finance the new equipment.
