The Bengal Township Board meeting was brought to order by Supervisor Schafer at 7:00 pm.

Members present: Deb Schafer, Bill Kushmaul and Denice Schultheiss; Nick McDonald, and Sharon Bassette absent.

The **Pledge of Allegiance** was said and the meeting commenced.

Supervisor Schafer moved to accept the **agenda** as presented, supported by Trustee Kushmaul, motion carried.

Consideration of the **08/14/19 meeting minutes** tabled until next month's meeting.

Treasurer Schultheiss presented the **Treasurer's Report.** Treasurer Schultheiss made a motion to approve the \$50k transfer from savings to checking made in August, supported by Trustee Kushmaul, motion carried.

Supervisor Schafer presented the **Clerk's Report** in the absence of Clerk Bassette. Supervisor Schafer made a motion to accept the Clerk's Report, supported by Trustee Kushmaul, motion carried.

Supervisor Schafer presented the **current bills to be paid.** Treasurer Schultheiss made a motion to replace the August checks issued to Cutting Edge and Sharon Bassette, with the payees signing an affidavit they will return the originals if ever found, and approved the Current Bills to be paid as presented, supported by Trustee Kushmaul, motion carried.

NEW BUSINESS:

Lawn and Snow: Supervisor Schafer presented the bids obtained for lawn and snow. General lawn and snow decision tabled until next month. The reseeding needs to be done soon, and Supervisor Schafer indicated it was offered to be done by Trustee McDonald at a lesser expense than either of the bids. Supervisor Schafer made a motion to approve Trustee McDonald to reseed the lawn areas in need if done for less than \$1200; otherwise to accept the next higher bid of \$1590.
