## Burn Permits 🐸

REMEMBER: Burn permits are required by residents. When either the Dallas Township or St. Johns Fire Department responds to a fire, the **PROPERTY OWNER is billed.** 

• Bengal Township residents living West of Francis Road can obtain a burning permit by contacting the Dallas Township Fire Dept. at 989-593-3146. Residents will be asked to leave their name, address, and phone number, what they are burning, and which days they wish to burn. Please call at least 24 hours in advance. If residents have any questions, call Vern Feldpausch, Dallas Township Supervisor, at 989-593-2768.

• Bengal Township residents living **East of Francis Road** can obtain a burning permit by contacting the **City of St. Johns Police Dept. at 989-224-6721.** You will be asked your name and address, what you are burning, how much you are burning, and when you wish to burn. Here, it is best to speak with someone to confirm your permit is approved. You are also able to apply to them for annual burn permits.

#### **Fire and Rescue Runs**

In the event of a fire run within the township, \$1,000 is charged when a fire truck is dispatched and/or \$450 when a first responder is dispatched. Bengal Township is charged \$1,000 for the first two hours and \$500 for every hour thereafter for fire service. When Bengal Township gets billed for these services, the property owner and/or person upon whom the service was provided, will be billed. Please check your insurance to see if Fire or First Responder services are covered. Typically, basic home-owners insurance only covers up to \$500. A small increase in your premium could save you money!

#### **Summer Tax Information**

Summer property taxes are payable **July 1 to September 14** by one of the following methods:

- Mail to: 1211 Hampshire Drive, St. Johns, MI 48879 (Preferred)
- In person on **Thursday September 14, 2023**, from 9:00 a.m. to 5:00 p.m. at the Township Hall 6586 W. M-21, St. Johns
- By appointment: Call 517-927-9273

**Please review your tax bill** for interest/penalty information. Checks or money orders are preferred, however cash payments for the <u>exact</u> amount owed will be accepted. There is no cash drawer in the office to make change.

**Deferment of Summer Taxes:** September 14<sup>th</sup> is the last day to file for the Summer Deferment per MCL21151(7). Certain taxpayers can apply to have their summer property taxes deferred until February. The requirements and application may be found at <u>www.michigan.gov/treasury</u>. There are generally two ways to qualify: 1) gross household income of \$40k or less and falling into an exemption classification, or 2) owning an agricultural or horticultural operation for which gross receipts are not less than house income.

**Did you know you could print your own receipt?** Property info and historical tax payments (only those paid **directly** to Bengal Township) can be viewed by the property owner online at <u>www.accessmygov.com</u>. BS&A provides the technical help using this webpage (1-855-BSA-SOFT).

**Need a receipt?** Receipts for tax payments are sent out only upon request. If you need a receipt, please indicate this when sending in your payment or contact the Township's Deputy Treasurer, Denice Schultheiss at 517-927-9273.
